TECHNICAL AMENDMENT A
TO

Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of licence Reg. No. P0182-01 granted on the 17/11/1997, as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects, is likely to have a significant effect on a European Site(s). In this context, particular attention was paid to the European site(s) at **Clooneen Bog SAC, Lough Forbes Complex SAC, Ballykenny-Fisherstown Bog SPA, Brown Bog SAC, and Annaghmore Lough (Roscommon) SAC**. The Agency considered, for the reasons set out below, that the activity is not directly connected with or necessary to the management of the sites as European sites and that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects will have a significant effect on a European site, and accordingly the Agency determined that an Appropriate Assessment of the activity was not required. **This determination is based on the distance and lack of connectivity between the installation and the European sites referred to above.**

Technical Amendment

In pursuance of the powers conferred on it by Section 96(1) (c) the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to **Glanbia (FP) Limited, Glanbia House, Kilkenny Co.** Kilkenny for an installation located at **Roosky, Co. Roscommon**.

Henceforth, the licence shall be read in conjunction with and the amendments set out below.

This technical amendment is limited to the following Condition.

Amendments

Amended Conditions

Amend Condition 1.4 of the licence, to read as follows.

- 1.4** Any reference in this licence to ‘site’ shall mean the **site layout and area of land shaded red as detailed on the map Drg No. IE572-006 Rev. D. submitted as part of a Technical Amendment A request received on the 27/07/2015.**

This technical amendment shall be cited as Amendment A to the licence.
