It is important to note that any objection to a proposed decision/request for an oral hearing **must be received by the Agency before the expiration of the appropriate period as specified in the accompanying notification.** An objection/request for an oral hearing must be made on-line on the Agency's website at www.epa.ie or by sending the objection or request by prepaid post to the Agency, or by leaving the objection or request with an employee of the Agency at the Headquarters of the Agency in Wexford during office hours, i.e. 9 a.m. to 5 p.m. Monday to Friday.

In accordance with Section 42(A) of the Waste Management Act 1996 as amended, the latest date for receipt of an objection is 5.00 pm on **8th January 2016.**
