In accordance with Article 36 of the Waste Management (Licensing) Regulations, the Agency hereby notifies you of its decision to grant a waste licence subject to conditions to Atlas Environmental Ireland Limited in respect of a facility at Atlas Environmental Ireland Limited, Clonminam Industrial Estate, Portlaoise, County Laois. Please find accompanying a copy of the Agency's decision.

I am to advise that the Agency's decision was made following consideration of an objection to the Agency's proposed decision in accordance with the Waste Management Act 1996 and related Regulations. Information relating to the objection and its consideration is available for inspection at the Agency's headquarters and at the offices of **Laois County Council** in accordance with the Regulations.

Also enclosed is a copy of a draft Guidance Note on Environmental Management Systems and Reporting to the Agency. Conditions of the waste licence for the above facility require that the Agency is notified of specified matters and that reports and other materials are forwarded at defined intervals. The draft Guidance Note is intended to assist you in the production of this information. It is the Agency's intention to complete a review of this document and publish it in 2004.

Please use the register number of the waste licence, 184-1, in any future communication in respect of same. Wexford*, and please include an original and three copies of all items in the correspondence.

The Agency recommends that you contact the Office of Environmental Enforcement (at the above address) to discuss the implementation of the conditions of the licence.
