The Directors considered a recommendation from the Office of Environmental Sustainability that the Agency approve the Recommended Determination to grant an Industrial Emissions Licence. The following documentation was submitted: Recommended Determination, 237 Third-party submissions and the Report of the Inspector dated 12 May 2016.

A copy of the licence application was available electronically.

Inspector's Report

The Directors noted the Inspector's Report. It was noted that the first sentence on page 24 of the report should have read 'A summary of the odour modelling results is set out in Table 1 below and this predicts that there will be no *adverse* impact due to odour emissions from the installation.'.

Delete the second definition of 'Agreement'.

Condition

- 2.2.2.13 Insert the following wording at the end of the condition: 'The Public Awareness and Communications Programme shall include a specific programme of outreach to interested local residents on matters relating to the prevention of nuisance and other factors at the installation. The programme shall be agreed by the Agency and a report on the programme shall be prepared and submitted to the Agency as part of the AER.'
- **3.2.1** Amend 'Emergency' to '*Energy*' for the condition to read as follows: '*Energy* efficiency, and'.

- **3.4.1** Amend the condition to read as follows: 'The licensee shall *maintain* an Installation Notice Board on the installation maintained thereafter.'
- **3.11.2c**) Delete 'unless agreed by the Agency' in the condition.
- **3.14.8** Delete the following wording from the condition: 'The licensee may accept up to 5 tonnes per annum of:
 - household hazardous waste and
 - hazardous waste from business customers and other non-household sources including farms that, because of its nature or composition, is similar to household hazardous waste,

at the civic amenity site.'

- **3.15a**) Amend the condition to read as follows: 'a fully enclosed building or enclosure capable of containing *any significant* emissions arising from the treatment and storage of construction and demolition waste;'
- **3.29** Insert as the final sentence of the condition to read as follows: '*No waste shall be burned in the biomass furnace*.'.
- **6.22.1** Amend the condition number to '6.23.1'.
- **6.22.2** Amend the condition number to '6.23.2'.
- **9.3** Renumber the second set of conditions to 9.4 and sub-conditions to be renumbered to 9.4.1, 9.4.2, 9.4.3 and 9.4.4. Consequently renumber 9.4 to condition 9.5, and 9.5 to 9.6.

C.1.2 Monitoring of Emissions to Air

In the table 'Emission Point Reference No: A2-1, A-1 (if operational), A2-6', delete the reference 'A-1(if operational)' to read as follows: 'A2-1, A2-6.

Following discussion, the Directors decided to grant a licence, as modified, to Nurendale Limited trading as Panda Waste Services Limited, for their installation at Rathdrinagh, Beauparc, Navan, County Meath, Register of Licence No W0140-04, subject to the conditions as set out in the licence.
