# TECHNICAL AMENDMENT B TO WASTE LICENCE

Licence Register Number:	W0033-01
Licensee:	Drogheda Borough Council (formerly Corporation of Drogheda)
Location of Facility:	Collon Road, Mell, Drogheda, Co. Louth



## **Reasons for the Decision**

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of licence Reg. No. W0033-01 granted on 30/12/1999 and amended on 18/6/2013 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 40(4) of the Waste Management Act 1996 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on a European Site. In this context, particular attention was paid to the European sites at River Boyne and River Blackwater SAC [2299], River Boyne and River Blackwater SPA [4232], Boyne Coast and Estuary SAC [1957] and Boyne Estuary SPA [4080] and the Agency considered, for the reasons set out below, that the activity is not directly connected with or necessary to the management of those sites as European Sites and that it can be excluded on the basis of objective scientific information, that the activity, individually or in combination with other plans or projects, will have a significant effect on a European site, and accordingly the Agency determined that an Appropriate Assessment of the activity is not required. The reasons for this determination are as follow:

- There is no direct discharge from the civic waste facility to surface water.
- There will be no change to existing operational practices and existing emissions.
- There is no record of the civic waste facility, as is, having an impact on a European site.

#### **Technical Amendment**

In pursuance of the powers conferred on it by Section 42B(1)(b) of the Waste Management Act 1996 as amended, the Agency amends Licence Reg. No. W0033-01, granted to Corporation of Drogheda.

Henceforth, the licence shall be read in conjunction with Amendment A issued on 18/6/2013 and the amendments set out below.

This technical amendment is limited to the following:

Condition 5.9.

### Amendments

#### **Conditions of Licence**

**5.9(d)** No hazardous waste (excluding waste oil and waste electrical and electronic equipment collected for recovery), asbestos, liquid waste, sludge or offal shall be deposited at the Civic Waste Facility.

*Delete condition 5.9(d) of the existing licence and replace with the above condition.* 

This technical amendment shall be cited as Amendment B (in pursuance of Section 42B(1) of the Waste Management Act 1996 as amended) to waste licence register number W0033-01.
