RE: Objection to Revised Waste Licence Application W0140-04 (Co Reg 115425) in respect of Nurendale Limited trading as Panda Waste Services Limited at Rathdrinagh Beauparc, Navan, Co. Meath

It has come to my attention that the Environmental Protection Agency has revised the about licence to give permission to Nurendale Ltd trading as Panda Waste Services Ltd to pollute our air with toxic materials (perfume odours), to collect slurry from all around Ireland (explosive fumes), to burn everything else when the wood cuttings have run out (another fire or explosion like 2012), to have a infestation of vermin like blue bottle flies & rats (summertime at 5pm in the evening), the having treatment in shredders of metal waste, including waste electrical & electronic equipment and end of life vehicles & their components (the burning of tyres – poisonous pollution into our environment.

Again to say the least I am horrified that you are allowing Air Pollution Odour/Perfume to be used to camouflage the air pollution that is caused by the waste material used at the above plant....a perfume odour that causes breeding and respiratory problems to all the people in the surrounding area of the plant. As from pervious experience when these perfumes were used the amount of times my children were put on inhalers and breeding apparatus to help them with their breeding because these perfumes were toxic, unhealthy and causing major health problems. Now you are giving this company the permission to endanger the health of my children, my family and myself...outrageous and unacceptable!

As I read further on in your document I find, which is more horrifying, that you are giving permission to Nuredale Ltd trading as Panda Waste Services Ltd to burn whatever they want if the wood cuttings is not available to burn....PERMISSION FOR ANOTHER EXPLOSION & FIRE!

Just let me recall your mind back to the time I wrote to your company about what me and my family experiences back in June, 2012 where there was a explosion and a fire that blazed for several days, a blazed that could not be controlled, could not be extinguished as the facility did not have the proper equipment in place for such a incident:

Quote "To say the least I am horrified to hear this especially after the fire in June 2012 and the after effects of the health and safety of my children and my mother. Just let me refresh part of my letter written to your department:

"This was happening to my three children and two of them very extremely bad that I didn't know if I was to take them to the hospital. The 14 year old has asthma and the 8 years had phenomena. They were extremely sick and vomiting all the time just like myself.

This sickness continued until Saturday when the smoke had finally gone. It was scarey and very frightening for my mother, my three children and myself having to live through this situation. No words can explain the sheer terror not knowing what we were breading into out bodies and what health damage that was done to our lungs and our body. For days it felt like you were dying and you couldn't get out of it because the smoke was smouldering and burning and the wind was blowing my way all the time.

It is and was any parent's worse nightmare. As it was pointed out to me, by telephone from that USA, that he would be coming home to find the pieces of his families bodies if Panda Waste had got the permission to build the Bio Gas Power Plant and you certainly wouldn't be reading this letter from me as you would have attended my mother's, my children's and my own burial by now. THE REASON FOR THIS IS THAT WE WOULD HAVE BEING BLOWEN UP TO TINY PIECES" Unquote

Also as I read further, I noticed that the company is going to make organic compose....horrified to hear this as like pervious we will have an infestation of blue bottle flies in the evening from 5pm onwards. We had this before and it was horrendous to say that I killed over 30 blue bottle flies in one summer's evening....the amount of contamination that these flies carried from this waste site into my home is totally frightening....no home should have to live under these circumstance....would you live like this? Having blue bottle flies invade your home knowing these were carrying contamination from a waste site, touching everything they land on....totally unacceptable.

Again with reference to my letter in February 2014 as stated the new criteria the government has implement on households in relation to the septic tanks.....now I hear that all the slurry from all over Ireland will be taken into this plant, thus causing more traffic congestion, air pollution and noise level". Again you are allowing this to happen...the air pollution will be deplorable! Even the Agricultural Department has put laws into place as to when farmers are allowed to spread slurry on their land and your Department is giving a free licence to Nurendale Ltd trading as Panda Waste Services Ltd to allow slurry from all over Ireland to be delivered to this site....the toxic fumes with everything else that could and will cause another fire or explosion.

As for the end of life vehicles and their components.....what is going to happen to the tyres and all the plastic associated with the car? Burning it and the black smoke and pollution that is caused with the burning of tyres and plastic....totally not acceptable in our world today especially was we are trying to promote a cleaner and better environment we are living in....and your company is allowing all of the above to take place in a rural agricultural environment...disgraceful!

Unfortunately due to past record **Nurendale Limited trading as Panda Waste Services Limited** has denied traffic congestion, air pollution and noise level. It took a recording and the time of the recording off the noise level to be submitted to your department for the above company to admit, in writing, that they were breaking this rule in relation to the criteria in running this plant. It took hard evidence for this to happen.

It is appalling to think that your department are being paid to ignore our complaints and let this plant do whatever they want. As stated in my letter in 2014 it was appalling that Nurendale Ltd were only applying for the building of a garage, shop/filing station and these buildings have being in operation for the last 12 years or more. Where is the justice in this?

The question how would you feel if it was your family that where living here and having to deal with this traffic congestion, air pollution and noise level from 4am in the morning until 2am at night. Also how would you feel

living in fear of an explosion that would wipe out you and your family or having to live through what happened in June 2012.

I sincerely hope you take my letter of complaint seriously and honestly investigate what happened in June 2012 and please do not allow for another EXPLOSION & FIRE TO TAKE PLACE
