TRANSFER OF AN INDUSTRIAL EMISSIONS LICENCE

Decision of the Agency, under Section 94 of the Environmental Protection Agency Act 1992 as amended

Licence Register No: W0178-02

The Agency, in exercise of the powers conferred on it by the Environmental Protection Agency Act 1992, as amended, for the reasons hereinafter set out, hereby transfers licence Register No W0178-02 and any associated amendments from Greenstar Holdings, Unit 6, Ballyogan Business Park, Ballyogan Road, Sandyford, Dublin 18 to Galway County Council, Aras an Chontae, Prospect Hill, Galway, County Galway.

Licence Register No: W0178-02 licenses the carrying on of the activities set out below at East Galway Landfill, Killagh More, Ballybaun (E.D. Killaan), Ballintober (E.D. Killaan), Ballinasloe, County Galway subject to twelve conditions, as set out in the Licence.

Activities Licensed:-

11.5	Landfills, within the meaning of section 5 (amended by Regulation 11(1) of the
	Waste Management (Certification of Historic Unlicenced Waste Disposal and
	Recovery Activity) Regulations 2008 (S.I. No 524 of 2008)) of the Act of 1996,
	receiving more than 10 tonnes of waste per day or with a total capacity
	exceeding 25,000 tonnes, other than landfills of inert waste.

The recovery or disposal of waste in a facility, within the meaning of the Act of 1996, which facility is connected or associated with another activity specified in this Schedule in respect of which a licence or revised licence under Part IV is in force or in respect of which a licence under the said Part is or will be required.

In accordance with Section 94 of the Act, Galway County Council, is deemed to have assumed and accepted all liabilities, requirements and obligations provided for in or arising under the licence, regardless of how and in respect of what period, including a period prior to the transfer of the licence, that may arise.

REASONS FOR THE DECISION

Pursuant to Section 94(5)(a) of the Act, the Agency is satisfied, on the basis of the information available, that Galway County Council is entitled to be regarded as a fit and proper person to be granted a like Industrial Emissions licence. Pursuant to Section 94(5)(b) of the Act, the Agency is satisfied, on the basis of the information available, that Galway County Council has made adequate financial provision to discharge the financial commitments or liabilities that will be entered into or incurred in carrying on each of the activities to which the licence relates, or in consequence of ceasing to carry on any of those activities. In reaching this decision the Agency has considered the application and supporting documentation received from the joint applicants and the Programme Officer's report.
