2. **Addendum to Recommended Decision on an Application for a Waste Licence**

The Directors considered a recommendation from the Office of Environmental Sustainability that the Agency approve the Recommended Decision to grant a Waste Licence. The following documentation was submitted: Recommended Decision, three submissions and Report of the Inspector dated 15 August 2016 and Addendum Report to the Inspector's Report dated 24 August 2016.

A copy of the licence application was available electronically.

Inspector's Report

The Directors noted the Inspector's Report and Addendum Report.

Recommended Decision

Amend the 4th paragraph of the Decision and Reasons for Decision to read as follows:

'In reaching this decision the Agency has considered the documentation relating to:

- the application, Register Number: W0290-01 and the supporting documentation received from the applicant;
- the submissions received;
- the Inspector's Report dated 15th August 2016;
- the Inspector's Addendum Report dated 24th August 2016;

Amend the 1st sentence of the 5th paragraph to read as follows: 'It is considered that the Inspector's Report dated 15th August 2016 and the Inspector's Addendum Report dated 24th August 2016 contain a fair and reasonable examination, assesses those effects.'

Conditions

8.1. Amend the condition to read as follows: 'The licensee shall, prior to is not contaminated. These criteria shall address at least the following parameters: mercury, lead and TBT.'

12 Amend Reason. Change format of text to remove strikethrough. Keep the text as follows:

Reason: To provide for adequate financing for monitoring and financial provisions for measures to protect the environment.
