## **Inspector's Report**

The Directors noted the Inspector's Report. It was noted that there was an error in last sentence and within table on page 13 of the report. The wording should have read:

'It is noted that the applicant modelled a higher emission value than the Directive would allow for oxides of nitrogen and sulphur dioxide, as follows:

Parameter	Modelled emission	Directive's limit
	value	value
NOx as NO <sub>2</sub>	$500 \text{mg/m}^3$	190mg/m <sup>3</sup>
Sulphur dioxide	$500 \text{mg/m}^3$	60 or 40mg/m <sup>3</sup>

## Glossary of Terms

Insert a definition for 'Odour control system' to read as follows: 'Includes the biofilter, ducting, fans for inducing negative pressure in buildings and vessels, the main building, the fibre store building and outdoor vessels used for the storage of incoming waste.'.

#### Condition

**6.1.2** Replace all references to 'abatement equipment/system' with 'odour control system'. The condition should read as follows: '

## Odour Control System

- a) The licensee shall prepare a test programme for the *odour control system* installed to abate emissions to atmosphere.
- b) The programme shall be completed within three months of the commencement of operation of the *odour control system*.
- c) The criteria for the operation of the *odour control system*, as determined by the test programme, shall be incorporated into the standard operating procedures.
- d) The test programme shall as a minimum:
  - establish all criteria for operation, control and management of the *odour control system* to ensure compliance with the emission limit values
    specified in this licence; and
  - assess the performance of any monitors on the *odour control system* and establish a maintenance and calibration programme for each monitor.
- e) A report on the test programme shall be submitted to the Agency within one month of completion.
- **6.14.4** Amend the wording to read as follows: 'All buildings *and the three outdoor vessels used* for the storage ... ... subject to treatment.'.
- 6.18 Delete the heading 'Nuisance Monitoring' and amend the condition wording to read as follows: 'The licensee shall, on a daily basis, inspect the installation and its immediate surrounds for *any* nuisances caused by vermin, birds, flies, mud, dust and odours. The licensee shall maintain a record of *these* inspections.

Following discussion, the Directors decided to grant a licence, as modified, to Timoleague Agri Gen Limited, for their installation at Barryshall, Timoleague, Bandon, County Cork, Register of Licence No P0986-01, subject to the conditions as set out in the licence.
