<p>The Agency granted an Industrial Emissions licence subject to conditions, on 13<sup>th</sup> October 2016 to Ormonde Organics Limited, Killowen, Portlaw, County Waterford, Reg. No. W0287-01, for 11.4(b) Recovery, or a mix of recovery and disposal, of non-hazardous waste with a capacity exceeding 75 tonnes per day located at Killowen, Portlaw, County Waterford.</p>
