In response to the Regulation 12 request for mation dated the 7<sup>th</sup> October 2016, please see below relevant information (3)

I am directed to advise you of a failure of compliance with Regulation 11 of the Waste Water Discharge (Authorisation) Regulations 2007 as amended. The notice as erected or fixed at the site contravenes Regulation 11(a) of the regulations. The notice as erected does not specify the National Grid Reference of the location of the associated current and proposed waste water treatment plants.

The Agency, therefore, requires you, in accordance with Regulation 12 of the regulations to erect an appropriate site notice in accordance with the requirements of the aforementioned Regulations. The notice shall be maintained in the position where erected or fixed for a period of at least one month from the date of this notice.

An appropriate site notice in accordance with the requirements of Regulation 11(a) of the Waste Water Discharge (Authorisation) Regulations 2007, as amended, was erected on the 11<sup>th</sup> of October 2017. A copy of the notice is appended to this response.

I am also directed to advise you of a failure of compliance with Regulations 10 of the Waste Water Discharge (Authorisation) Regulations 2007 as amended. The notice as published contravenes Regulation 10(b) of the regulations. The notice as published does not specify the National Grid Reference of the location of the associated current and proposed waste water treatment plants.

The Agency, therefore, requires you, in accordance with Regulation 12 of the regulations to publish a newspaper notice in accordance with the requirements of the aforementioned Regulations. The notice shall be published in a newspaper circulationg in the area in which the discharge takes place or is to take place.

A newspaper notice in accordance with regulation 12 of the aforementioned regulations identifying the National Grid Reference of the location of the current and proposed waste water treatment plant was placed in the Irish Examiner on the 13<sup>th</sup> October 2016. A scanned copy of the notice is appended and a hard copy of the original newspaper notice will be submitted to the Agency.

### Tusla gets extra €1m to inspect childminding services

The Child and Family Agency, Tusla, is to be given an extra €1m in funding next year to support its work in inspecting childminding

Childminding services will be under added pressure next year, when 48,000 extra children enter the system as part of the affordable childcare scheme, announced in Tuesday's budget.

Some 23,000 additional

children will enter the childcare system under the targeted supports, with a further 25,000 joining when universal support is introduced next September.

Children's Minister Katherine Zappone is confident the additional capacity exists. "So, we expect that there is room for the capacity to grow within the system, but there will be challenges and we are preparing for those in different ways," she said vesterday.

The minister said she was very aware of the concern the scheme would significantly increase the requirement for Garda vetting of childcare staff, and said she had been working with the Garda Vetting Bureau in the last few months to reduce the time taken to vet employees.

Fewer than 1% (150) of all childminders are registered with Tusla, and the minister's department will be encouraging more childminders to register.

The regulations state to register with Tusla, someone has to be minding more than three unrelated children outside the children's home.

Childminding Ireland, the national body for childminders, has been asked to see how more childminders could register and avail of the scheme.

Ms Zappone and her department are forming a working group to establish the supports and reforms needed for the sector.

Under a pilot scheme being run this year, some schools are allocated additional teaching time based on a range of factors other than simply their pupils' categorised disability or educational need.

Education Minister Richard Bruton announced in his 2017 budget that he plans to extend the system to all schools, aided by 580 extra resource teachers at primary and 320 at second

It is intended to replace the system under which some students wait longer to get support as their families or schools can not afford or access the required professional assess-

However, the resources have been proportionately reduced since 2011, when the weekly hours of resource teaching assigned each child was reduced by 10%, followed by a further 5% cut since

While resource teacher numbers have risen each year to reflect more children needing help in mainstream schools, those pupils continue to receive 85% of what they would have had before 2011.

The new model will give schools greater flexibility to distribute how their overall resource teaching allocation is shared, but they will still be operating from a smaller share per pupil than in the past.

Lorraine Dempsey, the chairwoman of the Special Needs Parents Association,

said that lost teaching time has still yet to be

"We're glad that it planned to roll out a new model from next year, meaning the altocation of extra teaching is based on educational need and not simply on category of dis-

"Bot we're still looking to have the 15% addressed in terms over overall, we still have a dilution of 15% there from 2012," she said.

Ms Dempsey said parents will also want assurances that there are adequate psychological and other supports in place to support schools under the revised

Mr Bruton said on Tuesday that the new system would free up members of the National Educational Psychological Service from having to carry out the assessments currently needed to allocate resource teachers.

He estimated that onethird of the 580 extra primary-level resource teachers will be over and above what would otherwise be allocated next year just to cater for extra numbers of pupils with special educational needs in line with overall school enrolment

Meanwhile, Mr Bruton should learn today if he faces industrial action and possible school closures by the Association of Secondary Teachers Ireland over equal pay for younger teachers, and the possible withdrawal from supervision and substitution duties at more than 400 second-level



#### **PUBLIC NOTICE** APPLICATION TO THE ENVIRONMENTAL PROTECTION AGENCY FOR A WASTE WATER DISCHARGE LICENCE

Pursuant to Regulations 9 of the Waste Water Discharge (Authorisation) Regulations, 2007 (S.I. No. 684 of 2007), as amended, Irish Water, Colvill House, 24-26 Talbot Street, Dublin 1, intend to apply to the Environmental Protection Agency for a Wastewater Discharge Licence for the Courtmacsherry Timoleague wastewater works. The existing wastewater works consists of two septic tanks, one primary discharge to the Argideen/Courtmasherry Estuary, six secondary discharges, two storm water overflows and two pumping

A new wastewater treatment plant is proposed on a greenfield site, 0.25 km to the west of the village and 0.5 km to the east of Ballynamona House in Cullenagh. The upgraded works will comprise the secondary treatment plant, extended sewers and new pumping station in Timoleague, a rising main transferring existing untreated wastewater for Timoleague to the new WWTP and a new pumping station in Courtmacsherry. Two existing secondary discharges will be replaced with two storm water overflows and four remaining secondary discharges will be removed. The primary discharge point will remain at the same location.
