**Re. Proposed use of Building 1 at Eras Eco for MSW transfer**

Dear Mr Dee

I refer to the meeting held between representatives of Eras Eco and the Agency on the 18<sup>th</sup> October 2011, and to your proposal to accept Municipal Solid Waste (MSW) at Building 1 of your waste licensed facility, W0211-01. The Agency notes that the proposed acceptance of MSW relates specifically to its bulking up and transfer only (as opposed to its treatment by mechanical segregation or by other means), and that additional odour control measures have now been put in place in that building (e.g. additional sealing of the building envelope, and provision of a new air handling and odour abatement system).

Based on the information provided, and subject to the Agency's requirements as outlined in previous correspondence on the use of Building 1 (e.g. GC05CN issued on 4/4/11), the Agency now agrees to the use of Building 1 for the acceptance and transfer of MSW.

In summary, the Agency has agreed to the following uses of Building 1 under waste licence W0211-01:


- the acceptance and transfer of MSW,
- the temporary storage of low odour sludges,
- the lime stabilisation of sewage sludge,
- the bulking up/transfer of Commercial Waste, and
- the storage/processing of waste wood/woodchip.

I wish to remind you of the obligations under the present licence with regard to the control of odour emissions from the facility, and should the Agency consider that the new air handling and odour abatement system for Building 1 is insufficient to control odour emissions adequately, the Agency may require additional odour control measures to be taken.
