TECHNICAL AMENDMENT C
TO
INDUSTRIAL EMISSIONS LICENCE

Licence Register Number:	W0165-02

Licensee:	Ballynagran Landfill Limited
Location of Installation:	Ballynagran, Coolbeg and Kilcandra, County Wicklow.

Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of licence Reg. No. W0165-02 granted on 23/3/2010 and amended on 2/8/2011, 15/1/2013 and 20/12/2013 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at Magherabeg Dunes SAC (Site Code: 001766), Deputy's Pass Nature Reserve SAC (Site Code: 000717), The Murrough Wetlands SAC (Site Code: 002249), The Murrough SPA (Site Code: 004186), Vale of Clara (Rathdrum Wood) SAC (Site Code: 000733), Buckroney Brittas Dunes and FEN SAC (Site Code: 000729).

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required.

The reasons for which the Agency determined that an Appropriate Assessment of the proposed activity is not required are as follows:

- The installation is not located within the above listed European Sites.
- There are no emissions to water courses from the installation and there will be no change on foot of the proposed technical amendment.
- There are no emissions to groundwater from the installation and there will be no change on foot of the proposed technical amendment.
- Storm water is passed through an oil interceptor before being collected on site in a lined surface water lagoon.
- Controls are in place to prevent discharge of contaminated storm water from the surface water lagoon.
- The activity will not result in damage to, or loss of, species and habitats of these European Sites.

Technical Amendment

In pursuance of the powers conferred on it by Section 96(1)(c) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to Ballynagran Landfill Limited, 23 Meadowfield, Sandyford, Dublin 18 for an installation located at Ballynagran, Coolbeg and Kilcandra, County Wicklow.

Henceforth, the licence shall be read in conjunction with a Section 76A(11) Amendment issued on 20/12/2013, Amendment A issued on 2/8/2011, Amendment B issued on 15/1/2013 and the amendments set out below.

This technical amendment is limited to the following:

Condition 1.

Condition 12.

Schedule D.

Amendments

Amend Condition 1 to include the following after Condition 1.12

- 1.13** Unless otherwise directed by the Agency, in addition to the maximum annual intake of waste authorised in Table A.1 and Table A.2 of *Schedule A: Waste Acceptance* of licence register number W0165-02 and for the period from the date of this amendment to 31/12/2016, the licensee may accept an additional quantity of waste, as follows:
- disposal within the void of the landfill: 40,000 tonnes of waste;
 - for use as daily cover: 15,000 tonnes.
- 1.14** Unless otherwise agreed by the Agency, the acceptance of waste under condition 1.14 shall be limited as follows:
- in relation to waste accepted for disposal within the void of the landfill, only municipal waste shall be accepted; and
 - in relation to waste accepted for use as daily cover, only the following shall be accepted:
 - inert waste,
 - waste soil and stone,
 - woodchip, and
 - bio-stabilised residual waste that meets the requirements of Condition 1.7.4 of this licence.

Amend Condition 12 to include the following after Condition 12.1.2

12.1.3 In addition to the annual contribution or revised annual contribution provided for in Condition 12.1.1 of licence register number W0165-02, the licensee shall pay to the Agency an additional contribution of €5,978, or such sum as the Agency determines, having regard to variations in the extent of reporting, auditing, inspection, sampling and analysis or other functions carried out by the Agency, towards the additional cost of monitoring the activity on foot of this amendment. Payment shall be made within one month of the date upon which demanded by the Agency.

Amend the "Ambient Odour" row of Table D.3.1 of Schedule D.3 as follows, all other elements of the table remaining unchanged:


