5. Recommended Determination of a Review for an Industrial Emissions Licence

The Directors considered a recommendation from the Office of Environmental Sustainability that the Agency approve the Recommended Determination to grant an Industrial Emissions Licence. The following documentation was submitted: Recommended Determination; Report of the Inspector dated 24 November 2016; and six Third-Party submissions. The Directors noted that this is a review of Industrial Emissions Licence Reg. No. W0184-01, issued by the Agency on 16 January 2004.

A copy of the licence application was available electronically.

Recommended Determination/Decision

Decision & Reasons for the Decision

Amend the 2nd page, 4th paragraph, 1st bullet point to read as follows: 'Many of the qualifying interests in the River Barrow and River Nore SAC are located a *significant* distance downstream is indirectly discharged.

Conditions

- **3.22.2** Amend the Condition to read as follows: 'Unless otherwise agreed by the Agency, all buildings for the storage or treatment of *waste* oil and oily wastes, solvent-based wastes, of this licence
- **3.22.6** Insert a new Condition to read as follows: 'Unless otherwise agreed by the Agency, the licensee shall, within 12 months of the date of grant of this licence, install and thereafter maintain and operate a regenerative thermal oxidiser at the installation.'.
- **5.2** Delete and replace the existing Condition wording with: 'There is no condition 5.2. in this licence.'.
- **5.9.19** Insert the text: 'Phone Number: 1890 278 278'

- **5.9.20** Delete the text 'Phone Number: 1890 278 278'.
- **6.18.1** Amend the Condition wording to read as follows: 'The licensee shall, within 3 months of the date of grant of this licence, prepare and thereafter maintain and implement an odour management programme prevented from recurring.
- **6.18.3** Amend the Condition wording to read as follows: 'The licensee shall prepare, maintain and implement a programme all relevant buildings where *waste* oil and oily wastes, solvent-based wastes, at least annually.
- **6.18.4** Amend the Condition to read as follows: 'Off-gases from the vapour-balancing ring main shall be subject to treatment by regenerative thermal oxidation or, *when the regenerative thermal oxidiser is not available*, carbon filtration before discharge.
- **6.19.9** Amend the Condition as follows: 'The regenerative thermal oxidiser shall be the preferred technique for the treatment and destruction of *new sources and emissions* of off-gases and ventilated gases that sets out the following:
 - whether the regenerative thermal oxidiser is a suitable technique for the gas concerned; *and*
 - why the proposed alternative is preferred (e.g. financial, technical, environmental reasons); and
 - how the proposed alternative is BAT.

This condition (6.19.9) shall apply after the commencement of the test programme for the regenerative thermal oxidiser as required under condition 6.1 of this licence.
