## Clerical or Technical Amendment Application Details

### Proposed Alteration Description

A change is requested to the Site boundary of Wyeth Nutritionals Ireland Ltd. to incorporate the area of a New Car Park located on the opposite side of the public road on the western side of the site as shown in the attached drawing C-000-014.pdf.

The Project comprises the construction of a car park with 156 car park spaces to replace a portion of the existing car parking area on the Wyeth site. This will allow for potential expansion of existing buildings on the Wyeth Site in the future.

This boundary expansion is required to accommodate the connection of the storm water drainage for the new car park into the existing storm water drainage network within the current site boundary. As notified by Ms. Mary Sheehan (EPA Inspector) from Office of Environmental Enforcement, South/ South-West Region, the proposed change to the storm water drainage system cannot be accommodated under 1.4 of the IE Licence P0395-03.
