## ***Reasons for the Decision***

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of licence Reg. No. **P0395-03** granted on **28/07/2011 (and amended on 16/12/2013)** as well as any amendments noted herein, any emissions from the activities will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activities, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at **Lower River Shannon SAC (002165) and River Shannon and River Fergus Estuaries SPA (004077)**.

The activities are not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activities, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activities was not required. **The reasons for this determination are:**

- **The changes do not substantially change the nature or extent of the operations or emissions at the installation, from what was considered when Licence Reg. P0395-03 was granted.**
- **There will be a Class I separator serving the car park area. There are also storm water controls and monitoring requirements as specified in Licence Reg. P0395-03. Therefore it is unlikely that there will be any significant risk of pollution as a result of surface water run-off from the car park.**
- **The conditions of Licence Reg. P0395-03 in relation to protection of surface water and groundwater and the on-site infrastructure are sufficient to ensure that the activities will not impact on the qualifying interests of any European site.**

## ***Technical Amendment***

In pursuance of the powers conferred on it by Section 96(1)(c) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to **Wyeth Nutritionals Ireland Limited, Coolrahee, Askeaton, Co. Limerick** for an installation located at **Coolrahee, Askeaton, Co. Limerick**.

Henceforth, the licence shall be read in conjunction with a Section 82A(11) Amendment issued on **16/12/2013** and the amendments set out below.

This technical amendment is limited to the following Condition(s):

# ***Amendments***

## **New Conditions or Amended Conditions**

*Amend Condition 1.3 of the licence to read as follows:*

**Condition 1.3** For the purposes of this licence, the installation authorised by this licence is the area of land outlined in **red** on Drawing No. **C-000-014** entitled **'Site Location Map Site Boundaries'** of the **Technical Amendment** application **received by the Agency on 24/10/2016**. Any reference in this licence to "installation" shall mean the area thus outlined in **red**. The licensed activities shall be carried on only within the area outlined.

This technical amendment shall be cited as Amendment A to the licence.
