TRANSFER OF AN INDUSTRIAL EMISSIONS LICENCE

Decision of the Agency, under Section 94 of the Environmental Protection Agency Act 1992 as amended

Licence Register No: W0131-02

The Agency, in exercise of the powers conferred on it by the Environmental Protection Agency Act 1992, as amended, for the reasons hereinafter set out, hereby transfers licence Register No W0131-02 and any associated amendments from Midland Waste Disposal Company Limited to Advanced Environmental Solutions (Ireland) Limited, CRO No. 224173.

Licence Register No: W0131-02 licenses the carrying on of the activities set out below at Clonmagaddan, Proudstown, Navan, County Meath subject to twelve conditions, as set out in the Licence.

Activities Licensed:-

- 11.4(b) Recovery, or a mix of recovery and disposal, of non-hazardous waste with a capacity exceeding 75 tonnes per day involving one or more of the following activities, (other than activities to which the Urban Waste Water Treatment Regulations 2001 (S.I. No. 254 of 2001) apply):
- (i) Biological treatment
 - (ii) Pre-treatment of waste for incineration or co-incineration
- 11.1 The recovery or disposal of waste in a facility, within the meaning of the Act of 1996, which facility is connected or associated with another activity specified in this Schedule in respect of which a licence or revised licence under Part IV is in force or in respect of which a licence under the said Part is or will be required.

In accordance with Section 94 of the Act, Advanced Environmental Solutions (Ireland) Limited, is deemed to have assumed and accepted all liabilities, requirements and obligations provided for in or arising under the licence, regardless of how and in respect of what period, including a period prior to the transfer of the licence, that may arise.

REASONS FOR THE DECISION

Pursuant to Section 94(5)(a) of the Act, the Agency is satisfied, on the basis of the information available, that Advanced Environmental Solutions (Ireland) Limited is entitled to be regarded as a fit and proper person to be granted a like Industrial Emissions licence. Pursuant to Section 94(5)(b) of the Act, the Agency is satisfied, on the basis of the information available, that Advanced Environmental Solutions (Ireland) Limited has made adequate financial provision to discharge the financial commitments or liabilities that will be entered into or incurred in carrying on each of the activities to which the licence relates, or in consequence of ceasing to carry on any of those activities. In reaching this decision the Agency has considered the application and supporting documentation received from the joint applicants and the Programme Officer's report.
