## ***Reasons for the Decision***

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of licence register number W0232-01 granted on 1/12/2008 and amended on 7/1/2014 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at South Dublin Bay and River Tolka SPA [004024], South Dublin Bay SAC [000210], North Dublin Bay SAC [000206], North Bull Island SPA [004006], Howth Head SAC [000202], Rockabill to Dalkey Island SAC [003000] and Howth Head Coast SPA [004113].

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required. The reason for the determination is as follows: The amendment to interpretation of monitoring results under the licence will not have a significant effect on any European site.

## ***Technical Amendment***

In pursuance of the powers conferred on it by Section 96(1)(c) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to Dublin Waste to Energy Limited, Arthur Cox Building, Earlsfort Terrace, Dublin 2 for an installation located at Pigeon House Road, Poolbeg, Dublin 4.

Henceforth, the licence shall be read in conjunction with a Section 76A(11) amendment issued on 7/1/2014 and the amendments set out below.

This technical amendment is limited to the following:

### Schedule B.1 Emission Limits

#### *B.1 Emission Limits to Air*

Delete the final row of the table in *B.1 Emission Limits to Air* and replace with the following row:

Parameters	Units	Half-hour average	Daily average	Periodic
Carbon monoxide (CO)	mg/m <sup>3</sup>	100 <sup>Note 4</sup>	50 <sup>Note 5</sup>	-

Delete notes 4, 5, 6 and 7 of *B.1 Emission Limits to Air* and replace with the following notes:

- Note 4:** At least 95% of all 10-minute average values taken in any 24-hour period shall not exceed 150 mg/m<sup>3</sup> or all of the half-hourly average values taken in the same period shall not exceed 100 mg/m<sup>3</sup>.
- Note 5:** At least 97% of the daily average values over the year shall not exceed the emission limit value.

This technical amendment shall be cited as Amendment A to the licence.
