Dear Mr. O'Brien

I refer to your application for a licence review.

I am to advise in accordance with Regulation 10(2)(b)(ii) of the EPA (Industrial Emissions) (Licensing) Regulations 2013, that the following information is required in support of the application under Regulation 9 of the Regulations:

1. In the context of the recent publication of the BAT Conclusions for the intensive rearing of poultry or pigs in the Official Journal of the European Union as Commission Implementing Decision (EU 2017/302);
 - a. Review the installation activities against the relevant BAT Conclusion requirements as set out in the document referenced above and demonstrate whether your installation meets BAT requirements and how these requirements are satisfied. The format of the review report should be as per the template located at the EPA website at the following address <http://www.epa.ie/pubs/forms/lic/industrial%20emissions/> entitled "2017 BAT Conclusion for intensive rearing of poultry or pigs".
 - b. Tabulate all of the BAT conclusions from the CID document for the Intensive Rearing of Poultry or Pigs (Feb 2017). For each BAT conclusion, indicate whether it is applicable to your installation. The following details should also be included in your table.
 - c. For all applicable BAT conclusions, state if it is proposed to be put in place and the timeline for implementation. Details of any proposals must be provided. Where you do not propose to meet the requirements of a particular BAT conclusion, provide reasons and clear justification(s) [Regulation 9(2)(h)].
2. Clarify whether the developments that were permitted under planning permission ref 12/6635 have been constructed, confirming when construction was completed and if / when the new constructions were stocked. If development has not taken place provide a proposed timeframe for construction. [Regulation 9(2)(g)].
3. In the application, it is unclear if the water supply for the activity is to be acquired from an existing private well or from a new private well within the site boundary. Clarify any sources of water used for the activity (existing and proposed) [Regulation 9(2)(f)].

4. Provide details of the estimated quantities of (1) electricity; (2) fuel; (3) feed to be used per annum for the activity (existing and proposed) [Regulation 9(2)(f)].
5. Clarify the annual organic fertiliser (pig slurry) production figure (in m³) for (i) the existing activity and (ii) for the installation once all expansion works have been completed [Regulation 9(2)(g)].
6. Clarify the annual organic fertiliser (pig slurry) storage figure (in m³) for (i) the existing activity and (ii) for the installation once all expansion works have been completed (total capacity minus the freeboard) and whether 26 weeks storage capacity is/will be available [Regulation 9(2)(g)].
7. Identify the location of all existing and proposed storm water discharge points / soakaways and associated monitoring locations, including a six digit grid reference (National Grid Reference (12 digit 6E, 6N) in each case [Regulation 9(2)(g)].


In addition to the above please also provide an updated non-technical summary to reflect the information provided in your reply.

The requested information should be submitted to the Agency within *six weeks* of the date of this notice, in order to allow the Agency to process and determine your application.

In the circumstances, you should make arrangements to have the required documents (1 signed original and 1 copy in hardcopy format, and 2 copies of all files in electronic searchable PDF format on CD-ROM) submitted to the Agency. Your response to this request should be directed to Elizabeth Leacy, Administration Officer, Office Environmental Sustainability.

It should be noted that the eight-week period within which the Agency is to decide the proposed determination will commence on the day on which this notice has been complied with. If you have any further queries please contact Ms Maire Buckley at the number above.
