Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of licence register number W0167-03 granted on 02/6/2015 and amended on 21/6/2016 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at River Boyne and River Blackwater SAC [002299], Boyne Coast and Estuary SAC [001957], River Boyne and River Blackwater SPA [004232], Boyne Estuary SPA [004080] and River Nanny Estuary and Shore SPA [004158].

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required. The reasons for this determination are as follows:

• The proposed amendment, in the context of the whole installation, does not have the potential for significant effects on any European site due to the nature and scale of the activity and the distance between the installation and designated sites.

Technical Amendment

In pursuance of the powers conferred on it by Section 96(1)(b) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to Indaver Ireland Limited, 4th Floor, Block 1, West Pier Business Campus, Old Dunleary Road, Dun Laoghaire, County Dublin for an installation located at Carranstown, Duleek, County Meath.

Henceforth, the licence shall be read in conjunction with Amendment A issued on 21/6/2016 and the amendments set out below.

This technical amendment is limited to the following:
