3. **Objection to a Proposed Determination of an Application for an Industrial Emissions Licence**

(i) *Licensee:* **Enva Ireland Limited**
Clonminam Industrial Estate

The Directors considered the following documentation: Proposed Determination issued on 6 December 2016, a First-Party objection received on 11 January 2017, two Third-Party objections received on 20 December 2016 and 11 January 2017, two submissions on objections received on 13 February 2017 and the Report and recommendations of the Technical Committee, Office of Environmental Sustainability dated 18 May 2017.

A copy of the licence application was available electronically.

Caitríona Collins and Brian Donlon gave verbal presentations.

Technical Committee Report

The Directors noted the Technical Committee Report and approved the recommendations of the Technical Committee with the following amendments:

Objection 5: Air emissions

The Directors rejected the amendment to Table A.2.2.

Objection 11: Wheel cleaning

It was agreed to amend Condition 3.19.3 to read as follows: ‘The wheel cleaners shall be used by all vehicles leaving the facility as required to ensure that *no contaminated* storm water or waste is carried off-site. All water from the wheel cleaning area shall be collected for safe disposal.’.

Objection 12: Air sparging

The Directors rejected the amendment to Condition 6.18.11.

Objection 14: Waste treatment

It was agreed to amend the 3rd bullet point of Condition 8.13 to read as follows:

- The purpose of the mixing operation shall be:
 - The production of waste-derived fuel for dispatch to an appropriate facility; or,

- *The mixing of other compatible wastes for ~~efficient~~ shipment to an appropriate facility.*

Objection 17: Emissions to air

It was agreed to amend Schedule B.1 to include a Note under each of the tables relating to the following Emission Point Reference Numbers: A3-52, A3-53, A3-54, A3-55, A3-56 and A3-57. The note should read as follows: *'The emission limit value stated shall exclude methane'*.

Following discussion, the Directors decided to grant a licence, as modified, to Enva Ireland Limited, for their Installation located at, Clonminam Industrial Estate, Portlaoise, County Laois, Register of Licence No W0184-02, subject to the conditions as set out in the licence.
