<p>The Agency granted a revised Industrial Emissions licence subject to conditions, on 15 June 2017 to Enva Ireland Limited, Reg. No. W0184-02, for Class 11.1: the recovery or disposal of waste in a facility, Class 11.2: disposal or recovery of hazardous waste with a capacity exceeding 10 tonnes per day, Class 11.4(a): disposal of non-hazardous waste with a capacity exceeding 50 tonnes per day, Class 11.4(b): recovery, or a mix of recovery and disposal, of non-hazardous waste with a capacity exceeding 75 tonnes per day and Class 11.6: temporary storage of hazardous waste, located at Clonminam Industrial Estate, Portlaoise, County Laois.</p>
