The Agency hereby notifies you of its decision to grant a licence, subject to conditions, to the above referenced facility.

All documentation relating to the is available to view on the Agency's website at www.epa.ie, including information on public participation and judicial review processes.

It should be noted that the Agency requires notification, in writing, from the licensee at least one week in advance of the commencement of the licensed waste activities, for compliance with Section 41(6) of the Waste Management Act 1996 as amended.

If your activity is yet to commence, you must provide adequate notice to the Office of Environmental Enforcement of the intended date of commencement of the activity. (See Appendix 1 attached).

Please note there is no requirement to acknowledge receipt of this letter.

Appendix 1- Licence Enforcement and Communication with the EPA

In order to facilitate the prompt and efficient enforcement of your license you are now required to contact the EPA without delay at edensupport@epa.ie supplying the following information:

- As a minimum, the name and email address for the primary contact for your facility in relation to enforcement of your license.
- The Agency strongly recommends that contact information is also supplied for a secondary and tertiary contact.

The licensee shall then be issued with a *username* and *password* for logging into this web based system; through which enforcement of the licence and communication with the EPA will largely be based. The primary, secondary and tertiary contacts will be the persons notified of any correspondence/notifications from the EPA.

The management and communication of any incidents to the EPA shall be in accordance with the EPA's Guidance; "Guidance on the Notification Management and Communication of Environmental Incidents" which can be accessed at:

All incidents must now be reported via the EDEN electronic communications web portal.
