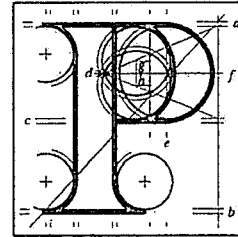

I have been asked by the Board to refer to the above mentioned appeal and, in particular, to the Board's notice to you under section 126 of the Planning and Development Act 2000, (as amended) in which it was indicated that the Board intended to determine this appeal before 21st September 2017.

I regret to inform you that, due to the necessity to issue a statutory notice, the Board will not now be in a position to determine the appeal before that date. In view of the delay involved in bringing this case to determination, priority consideration is being given to the case.

Most cases are decided within a short period of their being formally considered for the first time at Board level.
