

Dear Ms Oglesby,

I refer to the foul water discharge from the Eras Eco Installation at Foxhole. It has come to Eras Eco's attention that on the 30th January 2018 Irish Water commissioned the Foxhole Pumping Station. Since then the foul water discharges from Foxhole/Millennium Park, including that from the Eras Eco installation, no longer discharge to the estuary, but are pumped to the Youghal Wastewater Treatment Plant.
