Reasons for the Decision

The Environmental Protection Agency (the Agency) is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. D0034-01 granted on the 27 July 2010, and amended on 16 December 2016 as well as any amendments noted herein any discharge from the activity will comply with and not contravene any of the requirements of Regulation 6(3) of the Waste Water Discharge (Authorisation) Regulations, 2007, as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Site(s) at North Dublin Bay SAC, the South Dublin Bay SAC, the South Dublin Bay and River Tolka Estuary SPA and the North Bull Island SPA.

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required.

This determination is based on the fact that the proposed amendments will not result in a material change to the nature or volume of the discharges from the agglomeration.

Technical Amendment

In pursuance of the powers conferred on it by Regulation 33(1)(c) of the Waste Water Discharge (Authorisation) Regulations, 2007 as amended, the Agency amends Licence Reg. No. D0034-01, granted to Irish Water, Colvill House, 24/26 Talbot Street, Dublin 1.

Henceforth, the licence shall be read in conjunction with the amendment set out below.

This technical amendment is limited to the following Schedule of Licence Reg. No. D0034-01.

Amended Schedule

Amend Schedule A.4 Storm Water Overflows to read as follows:

Discharges from storm water overflows shall be as specified in Table D.1(iii)(a) of the application (as received on the 28 July 2008) and as set out in Table A.4.1 below.

Note 1: The licensee shall remediate storm water overflows identified under Condition 4.12 in accordance with the programme of infrastructural improvements prepared in accordance with Condition 5.3.
