TECHNICAL AMENDMENT B

INDUSTRIAL EMISSIONS LICENCE

Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Register Number W0020-02 granted on 24 March 2010 and amended on 15 January 2013 and 7 January 2014 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at Dundalk Bay SPA and SAC.

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required. The reasons are as follows:

- There are no European sites within 20km of the licensed facility; and
- The Dundalk Bay SAC and SPA are approximately 35km as the crow flies from the licensed facility and more than 44km downstream following the path of the River Fane.

Technical Amendment

In pursuance of the powers conferred on it by Section 96(1)(c) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to Monaghan County Council for an installation located at Letterbane, Annyalla, Castleblaney, County Monaghan.

Henceforth, the licence shall be read in conjunction with a Section 82A(11) amendment issued on 7 January 2014, Amendment A issued on 15 January 2013 and the amendments set out below.

This technical amendment is limited to the following:

- Condition 5.10.

Amendment


Amend Condition 5.10.4 of the licence to read as follows:

- 5.10.4 All unsorted domestic waste accepted at the civic waste facility shall be compacted within 12 hours. Unless otherwise agreed by the Agency, such waste shall be removed from the installation within 72 hours.

This technical amendment shall be cited as Amendment B to the licence.
