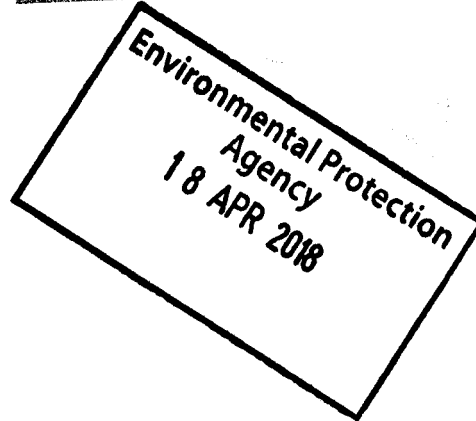
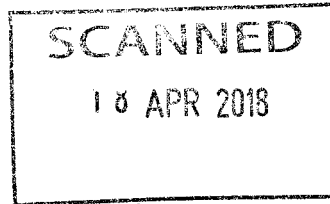


The EHS considered BAT Conclusions for the Food & Drink Manufacturing Sector when assessing the licence application. This office has no objection to the issuing of an Industrial
