Dear Mr. Murphy,

I refer to your application for a licence.

I am to advise in accordance with Regulation 10(2)(b)(ii) of the EPA (Industrial Emissions) (Licensing) Regulations 2013, that the following information is required in support of the application under Regulation 9 of the Regulations:

1.

- (a) In the submitted BAT Assessment document, tabulate all of the relevant BAT conclusions in Section 5.2 'Bat for Specific types of waste treatments' of the BREF document for the Waste Treatments Industries (August 2006) [Regulation 9(2)(h)].
- (b) In the submitted Bat Assessment document, the BAT Guidance Note for Disposal or Recycling of Animal Carcasses & Animal Waste Sector is listed as applicable. Tabulate all of the relevant BAT Conclusions from this document and clarify the applicability to the installation [Regulation 9(2)(h)].
- (c) For both (a) and (b) above, and where not already stated in the application, the following details should also be included in your tables [Regulation 9(2)(h)]:
  - For all applicable conclusions on BAT, state if it is proposed to be put in place and the timeline for implementation. Details of any proposals must be provided.
  - Where you do not propose to meet the requirements of a particular BAT conclusion, provide reasons and a justification.

2. As required under Regulation 9(2)(g), clarify the subsequent pathway of any water leaving the installation from the current and proposed Emission to Water Points SW1 and SW1a, and state whether the water discharges to ground or surface water. Submit an accompanying map illustrating the subsequent pathway.

3. The application states that 200 m<sup>3</sup> of gas and 1500 litres of diesel will be used at the installation per annum. Clarify the purpose and storage arrangement of these materials and clarify the type of gas to be utilised [Regulation 9(2)(g)].

In addition to the above please also provide an updated non-technical summary to reflect the information provided in your reply.

The requested information should be submitted to the Agency within **8 weeks** of the date of this notice, in order to allow the Agency to process and determine your application.

In the circumstances, you should make arrangements to have the required documents (1 signed original and 1 copy in hardcopy format, and 2 copies of all files in electronic searchable PDF format on CD-ROM) submitted to the Agency. Your response to this request should be directed to Dorota Richards, Administration Officer, Office Environmental Sustainability.

It should be noted that the eight-week period within which the Agency is to decide the proposed determination will commence on the day on which this notice has been complied with. If you have any further queries please contact Luke Heffernan at the number above.
