Article 34 of the Waste Management (Licensing) Regulations in respect of a licence application from Harp Refrigerants Limited for a facility located at Harp Refrigerants Limited, Unit 2, Whitestown Industrial Estate, Whitestown Road, Tallaght, Dublin 24.

Dear Ms Neary

The [Environmental Data Exchange Network \(EDEN\)](#) is being upgraded to enable applications for a licence/licence review to be processed electronically.

These changes involve the creation of a new EDEN application called '*Authorisation Module*'. Initially, the '*Authorisation Module*' will allow the Agency to issue letters and notices associated with the later phase of the licensing process. The functionality also provides for you to respond to requests for further information via EDEN, where requested to do so. (This functionality will be expanded in the future).

The aim is to:

- Reduce paper based correspondence through the use of electronic communication.
- Improve our customer and stakeholder experience.
- Streamline our processes.

Your current licence application (Reg. No.: W0297-01) will be progressed via this new process.

Please complete the following:

- A. If you have not already done so, you need to sign up and register for EDEN.

- **When registering a new organisation in EDEN (i.e., an organisation that has not previously been registered) please enter the organisation name exactly as it appears on your Licence Application Form.**
- When selecting the modules that you want to access, you should select '*Authorisation Module*' (required to access licence application/review correspondence and to interact with the Office of Environmental Enforcement (OEE) following the grant of a final decision on your application/review).

What will this mean to you?

1. *Appendix 1* overleaf includes the names and contact details of the people in your organisation the Agency will correspond with as ‘**Contact(s) for Correspondence**’ and ‘**Contact for Licence Issue**’. (These contact details originate from your licence application form).
 - A ‘**Contact for Correspondence**’ will be notified via e-mail when any notice or letter is issued, via the new ‘*Authorisation Module*’ of EDEN, on the application for a licence/ review. There can be multiple ‘**Contact(s) for Correspondence**’.
 - The ‘**Contact for Licence Issue**’ is the person to whom the final decision on the application for a licence/ review will issue (via post). There can only be one ‘**Contact for Licence Issue**’.

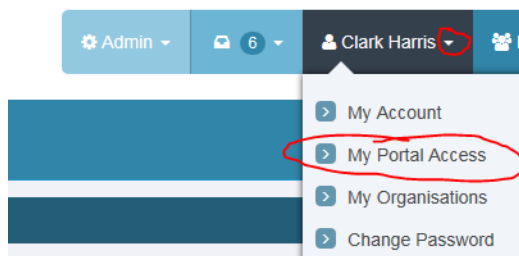
Please review the contact details included in *Appendix 1*, and if you require a change, or to add an additional ‘**Contact for Correspondence**’, please e-mail the request to: licensing@epa.ie.

2. Whenever a letter or notice is issued to the new ‘*Authorisation Module*’ area of EDEN, each ‘**Contact for Correspondence**’ will receive an e-mail, with a hyperlink, advising them of this new correspondence.
3. When the Agency makes a decision on your licence application/review, the final decision will be issued (via post) to the ‘**Contact for Licence Issue**’.

Note: The final decision on your licence application will continue to be issued to you by post.

To gain access to the ‘*Authorisation Module*’ in EDEN (where you do not currently have access) you will need to:

1. Log into EDEN and click on the small arrow next to your name, then select ‘*My Portal Access*’ (See screenshot below).



2. Click on the ‘Request Access’ button against ‘*Authorisation Module*’ from the ‘*Other Modules*’ list.
3. Click on ‘*Submit Request*’.

Please complete Steps 1 to 3 (detailed above), if applicable, as soon as possible after receipt of this letter.

On approval of your request by the Agency, the ‘*Authorisation Module*’ application will be available to you under the ‘*EDEN Modules*’ tab. You will then be able to access any further notices and letters issued to you on your licence application.
