Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0078-03 granted on the 21st December 2009, (and amended on 28th June 2010, 15th January 2013 and 19th December 2013) as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at Kilduff, Devilsbit Mountain SAC (Site Code: 000934), Scohaboy (Sopwell) Bog SAC (Site Code: 002206), Sharavogue Bog SAC (Site Code: 000585), Lough Derg, North-east Shore SAC (Site Code: 002241) and Slievefelim to Silvermines Mountains SPA (Site Code: 004165).

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required.

The reasons for which the Agency determined that an Appropriate Assessment is not required are as follows:

- The activity is not located within the above European Sites.
- The activity will not result in damage to, or loss of, habitat in these European Sites.
- The proposed change to the installation's boundary will not result in any new emission from the installation.

Technical Amendment

In pursuance of the powers conferred on it by Section 96(1)(c) of the Environmental Protection Agency Act 1992, as amended, the Agency amends the licence, granted to Tipperary County Council, Civic Offices, Limerick Road, Nenagh, County Tipperary for an installation located at Ballaghveny Landfill, Ballymackey, County Tipperary.

Henceforth, the licence shall be read in conjunction with Technical Amendment A issued on 28th June 2010, Technical Amendment B issued on 15th January 2013, Section 76A(11) Amendment issued on 19th December 2013, and the amendments set out below.

This technical amendment is limited to the following Condition:

Amendments

Amended Conditions

Amend Condition 1.4 of the licence, to read as follows:

Condition No. 1.4 For the purposes of this licence, the installation authorised by this licence, is the area of land outlined in red on Drawing titled 'Original and proposed Waste Licence Boundary' (Drawing date: 24 April 2018) received in support of the Licence Alternation Request submitted to the Agency on 14th November 2017. Any reference in this licence to "installation" shall mean the area thus outlined in red colour. The licensed activities shall be carried on only within the area outlined.

This technical amendment shall be cited as Amendment C to the licence.
