1. RECOMMENDATION

As the carrying on of the activity to which Waste Licence Reg. No. W0242-01 relates has not been substantially commenced within a period of three years beginning on the date on which the licence was granted or within the period of the two extensions granted by OCLR and OEE under Section 49[1][2]of the Waste Management Act 1996 as amended, I recommend that the OEE:

- 1. Issue a letter of notification to Padraic Thornton Waste Disposal Ltd; under Section 49(1) of the Waste Management Act 1996 as amended stating that the licence has ceased to have effect from 24/11/2015 and the activity cannot now commence under this licence.
- 2. Notifies Dublin City Council of the above.
- **3.** Make the relevant amendments to the OEE database and notifies the other internal offices [OES, Accounts] to reflect the change in the licence's status to ceased.

2. SUMMARY

Padraic Thornton Waste Disposal Ltd. (Trading as Thornton's Recycling), the licensee, was granted a waste licence by the Agency on the 24/11/2008 for the operation of a non-hazardous Materials Recovery Facility at Millennium Business Park, Cappagh Road, Grange, Dublin 11.

3. FACILITY LOCATION AND HISTORY

The facility is located in a greenfield site in Millennium Business Park, Dublin 11. There are a large number of commercial units within 1km of the site, in keeping with the industrial zoning of the area. The licensee was granted waste licence Reg. No. W0242-01 on 24/11/2008 to carryout non-hazardous waste activities with Class 13 of the fourth schedule of the Waste Management Acts 1996, as amended, identified as the principal activity.

The site infrastructure was to include a materials recovery building for sorting, processing and recovery as recyclables however the site was never developed.

4. AGENCY'S ASSESSMENT

Known contamination:

This development was proposed to be situated on a greenfield site. No known contamination issues were referred to in the Inspectors Report prepared during the licensing process. Based on a site visit to Thornton's Recycling Centre W0242-01 on the 13/01/2016 it was determined that the activity for which the facility was licensed did not substantially commence within a period of three years and the subsequent two extensions granted by the Agency (two years each). The site was observed to be a greenfield site with no development of the site to carry out the licensable activity haven taken place.
