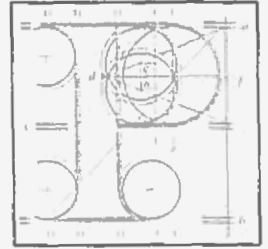

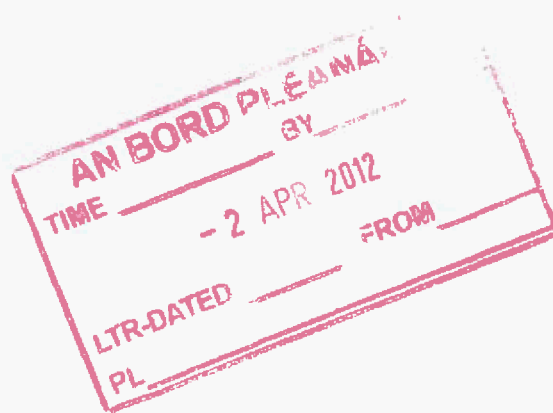
We refer to the above. There are significant issues to be addressed.

Development was granted by An Bord Pleanála in 2004 (01.EL2020) for extension of landfill, new site entrance, site office and civic amenity site and four engineered cells. It is noted that cell 17 and 18 remain unfilled since cessation of activities on 21<sup>st</sup> January 2012.

The status of site for continued operation as waste transfer site is not explained. Environmental Protection Agency Waste Licence W0025-03 applies to this site. Condition 12.5 of the Environmental Protection Agency Licence required a community fund of €1 per tonne of waste. This has been set up and currently stands at €130,000.

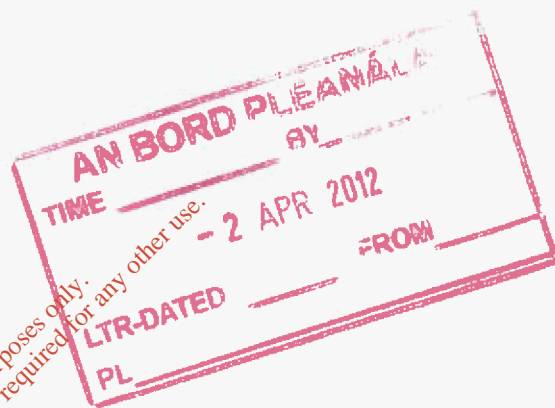
