

The Authority has received referral of the above proposal and submits the following observations for the Boards consideration;

The Authority notes the location of the subject site in close proximity to junction 6 on the M9 and requests that the Board has regard to the provisions of the Spatial Planning and National Roads Guidelines for Planning Authorities (DoECLG, 2012) in the consideration of the application.

Although the Authority notes that to Traffic and Transport Assessment (TTA) has been submitted in relation to the subject development application before the Board, the Authority previously recommended as part of EIS Scoping that the proposal be subject to TTA subject to meeting the appropriate thresholds and criteria and having regard to best practice.

While the application details submitted indicate that the scheme promoter has determined that a TTA is not required in this instance, the Authority defers to the Boards experience and role as planning authority to assess and determine if a TTA is required.
