Dear Mr Mustafa,

I am to refer to documentation received by the Agency in respect of an application for a review of a waste licence on 23/02/2015 in respect of a facility at Rehab Glassco Limited, Unit 4 Osberstown Industrial Park, Caragh Road, Naas, County Kildare. Having examined the documentation submitted, I am to advise that the Agency is of the view that the documentation does not comply with Article 13 of the Waste Management (Licensing) Regulations.

You are therefore requested, in accordance with Article 14(2)(b)(ii) of the Regulations, to take the steps and supply the information detailed below:

ARTICLE 13 COMPLIANCE REQUIREMENTS

Air Dispersion Model:

The air emissions monitoring at emission point 'A1' carried out on 12th March 2015 demonstrate that the carbon monoxide from the activity was in exceedance of the emission limit value.

- a. Provide an explanation for this non-conformance and its impact on ground concentrations having regard to the air dispersion modelling carried out for the site
- b. With reference to the Air Dispersion Modelling Assessment Report No. 2015034(1), provide detailed table of results of air dispersion modelling for each of the emission points A1 and A2 as follows:
