Following on from our recent conversation of 21/06/18, and previous correspondence dated 01/02/18 and 03/05/18 in relation to Notice in accordance with Article 16(1) of the Waste Management (Licensing) Regulations 2004.

It has taken longer than anticipated to complete an "Environmental Assessment and Risk Assessment Report of Phase 2 Restoration Area" which will be incorporated in the response to further information/updated EIAR. We are also still awaiting a number of final reports from subconsultants with respect to completing the EIAR which have been delayed for a number of reasons including delays in undertaking fieldwork and holidays.

Ewa,

Following on from our earlier conversation this morning and previous correspondence dated 01/02/18 in relation to Notice in accordance with Article 16(1) of the Waste Management (Licensing) Regulations 2004.

As discussed, due to the prolonged period of inclement weather and as a consequence poor ground conditions on site, it was only possible to undertake the ground investigation works last week.

As you are aware a previous ground investigation programme of 13 trial pits was carried out in support of the original waste licence application in 2009. 5 No. ground water monitoring wells were also installed on site.

A focused ground investigation programme involving the drilling of six shell and auger holes and 18 trial pits was completed in April 2018. Soil samples have been forwarded for laboratory analysis. It is estimated that it will take up to three weeks for the laboratory analysis and another 3 weeks for the hydrogeologist to complete the reporting requirements on the ground investigation.

A surface and groundwater monitoring programme was also conducted in March 2018 and the results will be incorporated in the response to further information/updated EIAR.

Given the above unforeseen circumstances, and the need to incorporate the findings of the ground investigation into the revised EIAR it is considered that an extension of time until **2nd July 2018** is necessary

with respect to submission. We would be grateful if you could respond in writing to our request at your earliest opportunity given the current deadline of 7th May 2018.
