- 1. I undertake to notify the Water Services Section of Louth County Council and obtain permission before opening the public roadway/footpath/grass verge and to abide by regulations made by the said Council and pay any fees or deposits as required.
- 2. I undertake to construct the drain on my premises and the outfall drain to the main sewer of proper materials and in a skilful and workmanlike manner and in accordance with the following particulars:-

### **PIPES**

The drains shall be constructed of uPVC pipes and fittings or other equally suitable material. The pipes shall be of adequate size. A minimum of a 150mm diameter pipe is required to service 2 or more houses. The junction with the Council's sewer is to be made with an approved saddle piece or branch and shall be entirely enclosed in concrete (4 to 1) extending 150mm outside the pipework all around.

#### CONCRETE BED

Where laid in soft ground or under a building used for human habitation, the pipes shall be wrapped in plastic with a 150mm concrete surround (6 to 1), extending 150mm beyond the exterior diameter of the pipes.

#### CONSTRUCTION

The drains shall be laid in a direct line for the whole distance beneath any building and between inspection chambers. The drains shall be laid with adequate falls and no right angled junction either vertical or horizontal shall be constructed in such drains.

#### VENTILATION

Adequate means of ventilation of the drains shall be provided.

- 3. I undertake not to construct such drain or to run into the house drain or be connected with the house drain of any adjoining building, except in special circumstances and under conditions to be approved of by you. In such event a written agreement is to be borne by the owners of the properties
- 4. In the event of two or more separate houses, buildings or premises being connected by one system of drains and thence by a single drain to the main sewer in special circumstances as provided in Clause 3 or otherwise, it is hereby agreed by all parties concerned that no part of the system of drains, or of the outfall to the main sewer, shall constitute a public sewer within the meaning of the Public Health Acts or of any of the amending Acts.
- 5. I undertake to notify the Council or their Officer at least 24 hours before commencing the work and to afford proper facilities for inspection of the work before same is covered in and to carry out any instructions, which may be given by the Council's Officers as to the relaying or rejoining of pipes uncovering any part of the work or the materials used therein.
- 6. I undertake that no injury shall be done to the main sewer in the execution of the work, nor shall any debris be allowed to enter the sewer at the point of connection and to indemnify the Council against all cost incurred by the Council as a result of the construction of the work.
- 7. The extended sewer when laid and approved of by the Council shall be taken over and maintained by the Council with a right to grant further service connections on the conditions laid down herein.
- 8. Where a licence to discharge trade effluent to sewers which is issued under Section 16 of the Local Government (Water Pollution) Act, 1977, as amended in 1990 is required or where the requirement for such licence is conditioned in the planning conditions, the applicant shall apply for and obtain such licence prior to connection to the sewer.
