Dear Louth County Council,

This letter constitutes your Connection offer ("**Offer Letter**") for Water Services to your Premises.

In response to your application for a Connection (your "**Application**"), Irish Water is pleased to issue you with this Offer Letter on the terms set out herein and as set out in Irish Water's General Conditions for Domestic and Non-Domestic Water and Wastewater Connections (the "**General Conditions**", copy attached), and any Specific Conditions pertaining to this connection as attached.

We would encourage you to read this Offer Letter and the General Conditions. If you are satisfied with this Offer Letter and the General Conditions, any specific conditions and wish to accept the offer outlined, you must, return to Irish Water the counterpart Offer Letter duly signed by you together with payment of the Connection Charge.

Words and phrases used in the Offer Letter and not otherwise defined, shall have the meaning given to those terms in the General Conditions.

The terms of this offer are based on the information submitted with your Application.

## 1. Irish Water's Offer

This Offer Letter together with the General Conditions form Irish Water's offer for a Connection.

## 2. Acceptance of Offer

This offer is valid for three (3) months from the date of issue of this Offer Letter. Thereafter, this offer will lapse unless otherwise agreed in writing by Irish Water.

This offer may be accepted by returning the following to Irish Water:

1. A signed copy of the counterpart to this Offer Letter; and
2. payment of the Connection Charge,

together the "Acceptance Requirements". By accepting this offer you shall be deemed to have accepted the General Conditions.

## 3. Connection Charge

The Wastewater connection charge is €10

The Total Connection Charge is €10 ("Connection Charge")

## 4. Local Authority

Your Connection will be managed by Louth County Council on behalf of Irish Water in accordance with the General Conditions.

## 5. Connection Works

Once the Acceptance Requirements have been satisfied, Irish Water shall request the Local Authority to make contact with you to schedule the Connection.

## 6. Distribution System, Drains and Service Connection

We would draw your attention to your obligations under the General Conditions to provide, maintain and renew the Distribution System and/or Drains and Service Connection required for the provision of Water Services.

## 7. Cancellation by the Customer

You may cancel the proposed Connection, by writing to Irish Water at the contact address set out below quoting the 'Our Reference' set out in this Offer Letter, within seven (7) Business Days of the accepting this offer without incurring any charges, unless the Connection has been carried out before the end of such period with your agreement. If you cancel the Connection in accordance with this paragraph, Irish Water will refund any payment which you have already made for the proposed Connection.

## 8. Connection Agreement

Once you have satisfied the Acceptance Requirements, this Offer Letter together with the General Conditions, any specific conditions shall constitute a legally binding and effective contractual agreement between the parties and shall together be referred to as the "Connection Agreement". The Connection Agreement shall constitute the entire agreement between the parties.
