Appendix 1- Licence Enforcement and Communication with the EPA

In order to facilitate the prompt and efficient enforcement of your license you are now required to contact the EPA without delay at edensupport@epa.ie supplying the following information:

- As a minimum, the name and email address for the primary contact for your facility in relation to enforcement of your license.
- The Agency strongly recommends that contact information is also supplied for a secondary and tertiary contact.

The licensee shall then be issued with a *username* and *password* for logging into this web based system; through which enforcement of the licence and communication with the EPA will largely be based. The primary, secondary and tertiary contacts will be the persons notified of any correspondence/notifications from the EPA.

The management and communication of any incidents to the EPA shall be in accordance with the EPA's Guidance; "Guidance on the Notification Management and Communication of Environmental Incidents" which can be accessed at:
