AA Screening Determination:

That the activities are not directly connected with or necessary to the management of any European Site and that it can be excluded, on the basis of objective information, that the activities, individually or in combination with other plans or projects, will have a significant effect on any European Site, and accordingly determined that an Appropriate Assessment of the activities was not required.

This determination is based on the following:

1. The 'Good' Water Framework Directive status of the Carrigboy River (also referred to as the Four Mile (Water) River) (IE_SW_21F020500) into which the discharges from the agglomeration discharge.
2. The capacity of the receiving water to assimilate the discharges from the agglomeration,

therefore, not having a significant effect on any European Sites.
