Hello Brian,

GCC uploaded a change request on EDEN for license # W0178-02 on Wednesday last, 2nd August. This was the agreed course of action following a meeting with EPA inspectors Mick Henry & Kealan Reynolds the day before in Carrick-on-Shannon. The inspectors suggested that in addition I send an e-mail outlining the urgency of the request. To fill you in briefly, the amendment application is a request to increase the annual waste recovery license limit to address an infilling requirement that has arisen from consents granted to the previous licensee. The urgency arises as the areas affected are the older sections of the landfill which the Agency have requested GCC to cap as matter of priority. GCC have presently a contractor on site to commence final capping but areas need to be infilled with recovery material in advance and allow a period for settlement.
