4. **Recommended Decision on an Application for a Waste Licence**

Licensee: **Kilsaran Concrete Unlimited Company
Tullykane
Kilmessan
Meath**

Register of Licence No: **W0296-01**

The Directors considered a recommendation from the Office of Environmental Sustainability that the Agency approve the Recommended Decision to grant a Waste Licence. The following documentation was submitted: Recommended Decision; and Report of the Inspector dated 8 November 2018.

A copy of the licence application was available electronically.

David Flynn, Karen Creed and Ewa Babiarczyk gave verbal presentations.

Inspector's Report

The Directors noted the Inspector's Report. The Board noted an error in the reference to Financial Provision under the heading Financial Provision in Section 16 which should note there is no requirement for Financial Provision in the Recommended Decision.

Recommended Decision

Introduction

Amend the second sentence of the first paragraph to read as follows: 'The activity relates to the deposition for the purposes of restoration of a quarry void using imported ~~natural~~ *inert greenfield and non-greenfield* soil and stone.'

Part II Schedule of Activities Refused

Refused waste disposal activities, in accordance with the Third Schedule of the Waste Management Act 1996 as amended

Amend brackets in Class D 15. to read as follows: 'Storage pending any of the operations numbered D 1 to D 14 (excluding temporary storage) being preliminary storage according to the definition of "collection" in section 5(1), pending collection on the site where the waste is produced.'

Amend the Reason to read as follows: 'Disposal of waste is not authorised at the facility *due to the risk of groundwater contamination. This facility is authorised as a recovery facility.*'

Refused waste recovery activities, in accordance with the Fourth Schedule of the Waste Management Act 1996 as amended

Amend the Reason to read as follows: ‘Metal waste and construction and demolition waste (other than waste soil and stone) are not authorised for acceptance at the facility suitable for deposit in unlined facilities due to the risk of groundwater contamination.

The exchange of waste for submission to any of the operations numbered R1 to 11 is not authorised at the facility. *The activities listed in R12 are not applicable for the operation of an unlined inert soil and stone recovery facility.*’

Conditions

8.13 Amend the condition to read as follows: ‘*Prior to the acceptance of waste at the facility the licensee shall develop..... the facility.*’

Schedule A: Limitations

Table A.1.1 Waste Categories and Quantities

Amend Note 2 to read as follows: ‘Unless otherwise agreed with the Agency, this is the maximum quantity of all soil and stone materials to be accepted for the backfill of the quarry ~~including waste soil and stones in a calendar year~~. as may be required by the Planning Authority.’

Table A.2 Waste Acceptance Criteria for Backfill Material

Amend the Minimum Criteria for Greenfield soil and stone to read as follows: ‘Letter of suitability *from a qualified person.*’

Following discussion, the Directors decided to grant a licence, as modified, to Kilsaran Concrete Unlimited Company, for their facility at Tullykane, Kilmessan, Meath, Register of Licence No W0296-01, subject to the conditions as set out in the licence.
