4. **Recommended Decision on an Application for a Review of a Waste Licence**

(i) *Licensee:* **Killarney Waste Disposal Unlimited Company**  
**Aughacurreen**  
**Killarney**  
**Kerry**

*Register of Licence No:* **W0217-02**

The Directors considered a recommendation from the Office of Environmental Sustainability that the Agency approve the Recommended Decision to grant a Waste Licence. The following documentation was submitted: Recommended Decision and Report of the Inspector dated 29 November 2018.

A copy of the licence application was available electronically.

### **Inspector’s Report**

The Directors noted the Inspector’s Report.

### **Recommended Decision**

#### **Introduction**

Amend bullet point (iii) to read as follows: ‘the storing of organic waste *for up to 48 hours (72 hours on public holidays); and*’

#### **Conditions**

**3.5.2** Amend the condition to read as follows: ‘**Within six months of the date of grant of this licence and prior to the increase of the facility’s maximum waste acceptance threshold from 40,000 to 59,000 tonnes per annum**, the licensee shall ensure that an impermeable concrete.... within five working days.’

**3.11** Amend the condition to read as follows:

‘Process Effluent

**The licensee shall, within three months of the date of grant of this licence and prior to the increase of the facility’s maximum waste acceptance threshold from 40,000 to 59,000 tonnes per annum, carry out an assessment... of the Agency.’**

**3.25.4** Amend the condition to read as follows: ‘**Within six months of the date of grant of this licence and prior to the increase of the facility’s maximum waste acceptance threshold from 40,000 to 59,000 tonnes per annum, all buildings for the storage.... by the Agency.’**

**3.25.5** Amend the condition to read as follows: ‘**The licensee shall maintain an and implement a programme.... least annually.**’

**6.15.6** Amend the condition to read as follows: ‘**Within three months.... shall identify the level of any process effluent contamination in the storm water collection system, settling tanks, silt trap, oil separator, glass reed bed, lagoon reed bed reed beds and percolation ditch. Any recommendations arising from this investigation and any additional measures required by the Agency shall be implemented following approval by the Agency and prior to the increase of the facility’s maximum waste acceptance threshold from 40,000 to 59,000 tonnes per annum.**’

**6.26** Insert the following new condition:

*6.26 Prior to the increase of the facility’s maximum waste acceptance threshold to greater than 40,000 tonnes per annum the licensee shall complete, to the Agency’s satisfaction:*

- (i) Condition 3.5.2 in relation to the provision of impermeable concrete surfaces;*
- (ii) Condition 3.11 in relation to the assessment of the on-site process effluent storage capacity;*
- (iii) Condition 3.25.4 in relation to the installation of negative air pressure and an air treatment system;*
- (iv) Condition 6.15.6 in relation to the investigation of the suitability of the storm water drainage and treatment system; and*
- (v) Condition 8.15 in relation to the removal of waste, equipment and deposited construction and demolition waste from outdoor areas of the facility.*

**8.15** Amend the first sentence of the condition to read as follows: ‘**Within six months of the date of grant of this licence and prior to the increase of the facility’s maximum waste acceptance threshold from 40,000 to 59,000 tonnes per annum, the following shall be removed from all outdoor areas of the facility:**’

**12.2.3** Amend the condition to read as follows: ‘The licensee shall to the satisfaction of the Agency ~~and prior to increasing the waste acceptance threshold from 40,000 to 59,00 tonnes per annum~~, make financial provision to cover *the operation of the site for 59,000 tonnes of waste per annum including any liabilities associated with the operation (including closure, restoration and aftercare).* The amount.... identified in Condition 12.2.1.’

## **Schedule C: Control & Monitoring**

### ***C.1.1. Control of Emissions to Air***

Replace Schedule C.1.1. with the following:

Emission Point Reference No: A-1

Description of Treatment: Carbon filter or alternative as agreed by the Agency.

Control Parameter	Monitoring	Key Equipment <sup>Note 1</sup>
Air extraction	Continuous with alarm/call-out	Pumps/ engines Pressure gauges
Fan	Daily visual check	System is operational
Negative pressure across the filter	Monthly	Air current tubes.
Other parameters as required by the Agency.		

**Note 1:** The licensee shall maintain appropriate access to standby and/or spares to ensure the operation of the abatement system.

***C.1.2. Monitoring of Landfill Gas Emissions***  
Replace Schedule C.1.2. with the following:

Emission Point Reference No: A-1

Parameter	Monitoring Frequency	Analysis Method/Technique
Odour	Quarterly	To be agreed with the Agency.

Following discussion, the Directors decided to grant a licence, as modified, to Killarney Waste Disposal for their facility at Aughacurreen, Killarney, Kerry, Register of Licence No W0217-02, subject to the conditions as set out in the licence.
