TECHNICAL AMENDMENT E

INDUSTRIAL EMISSIONS LICENCE

## ***Reasons for the Decision***

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0003-03 granted on 4 June 2003, (and amended on 9 August 2005, 16 December 2015, 22 April 2016, 20 July 2016 and 7 June 2017) as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Site(s) at Glenasmole Valley SAC, Wicklow Mountains SAC, South Dublin Bay SAC, Wicklow Mountains SPA and South Dublin Bay and River Tolka Estuary SPA.

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required. This determination is based on the fact that the proposed amendments will not result in a material change to the nature of the discharges from the agglomeration.

## ***Technical Amendment***

In pursuance of the powers conferred on it by Section 96(1)(c) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to South Dublin County Council, PO Box, 4122, Town Centre, Tallaght, Dublin 24 for an installation located at Ballymount Baling Station, Ballymount Road, Walkinstown, Dublin 12.

Henceforth, the licence shall be read in conjunction with a Section 82A(11) Amendment issued on 16 December 2015 and Amendment A issued on 9 August 2005, Amendment B issued on 22 April 2016, Amendment C issued on 20 July 2016, Amendment D issued on 7 June 2017 and the amendments set out below.

This technical amendment is limited to the following Condition(s):

## ***Amendments***

### **Amended Conditions**

*Amend Conditions 5.3.5, 5.4.1 and 7.1, of the licence to read as follows:*

- 5.3.5 Notwithstanding Condition 1.7, all waste accepted into the Bailing Centre, whether for treatment or transfer, shall be dispatched from the installation with 48 hours of arrival or 72 hours in the case of a public holiday.
- 5.4.1 The floor of the Bailing Centre shall be washed and cleared daily. The floor of the temporary waste storage bay shall be washed down weekly.
- 7.1 All waste shall be removed from the facility within 48 hours or 72 hours of a public holiday, unless subject to the prior agreement of the Agency.

This technical amendment shall be cited as Amendment E to the licence.
