TECHNICAL AMENDMENT B TO INDUSTRIAL EMISSIONS LICENCE

Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of licence Reg. No. **P0395-03** granted on **11/10/2012** (and amended on **16/12/2013** and on **10/01/2017**) as well as any amendments noted herein, any emissions from the activities will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activities, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Sites at River Shannon and River Fergus Estuaries Special Protection Area (SPA) (004077), Lower River Shannon Special Area of Conservation (SAC) (002165), Askeaton Fen Complex SAC (002279), Barrigone SAC (000432) and Curraghchase Woods SAC (000174).

The activities are not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activities, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activities was not required. **The reasons for this determination are:**

- The changes will reduce the maximum allowable emissions to air from the installation, compared to what is currently permitted.
- The requested changes represent a reduced impact on ambient air quality compared to what is currently licenced.

Technical Amendment

In pursuance of the powers conferred on it by Section 96(1)(c) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to **Wyeth Nutritionals Ireland Limited, Coolrahnee, Askeaton, Co. Limerick** for an installation located at **Coolrahnee, Askeaton, Co. Limerick.**

Henceforth, the licence shall be read in conjunction with a Section 82A(11) Amendment issued on 16/12/2013, Amendment A issued on 10/01/2017 and the amendments set out below.

This technical amendment is limited to the following Conditions and Schedules:
