



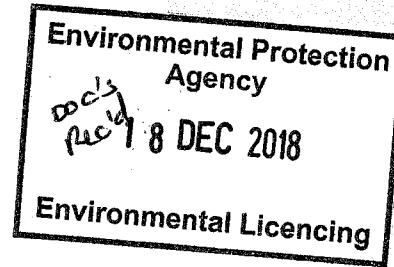

Dear Dr. Amajirionwu

Please find attached four completed COA application forms for Landfill No.2, Landfill No.3A, Landfill No.3B and Landfill No.3C in Fassaroe, Co. Wicklow. Each application contains the completed application form, the walkover survey checklist and a location map.

The other documents produced to accompany the applications comprise;

- Non-technical Summary – July 2018 (18 pages) - Attachment A.1 on the application form
- Environmental Risk Assessment – May 2018 (707 pages) and Remediation Strategy Report – July 2018 (43 pages) - Attachment D.1 on the application form.
- Screening for Appropriate Assessment and Natura Impact Statement – May 2018 (84 pages) - Attachment E.1 on the application form.

Hard copies of these four documents plus copies in pdf-format on CD-Roms were sent to the EPA in July 2018 with two COA applications for (i) Landfills No. 2 and 1, and (ii) Landfills Nos.3A, 3B and 3C. On the 30th November 2018, I wrote to you requesting that these applications be withdrawn and indicating that they would be replaced by these four new individual applications for Landfills No. 2, Landfill No 3A, Landfill No. 3B and Landfill No. 3C. I write to request that the hard copies of the four documents listed above that were submitted in July 2018 be used as the accompanying documents for these four new applications. These documents are the reports that are required by Attachment A.1, Attachment D.1 and Attachment E.1 on the application forms.

I can provide additional hard copies of these documents to the EPA if they are required.


