Dear Sirs,

In relation to the above, we note the current extension expires on April 11th, i.e. next Tuesday. In this regard, we might refer you to the various submissions to EPA from the undersigned and from Jacinta Somers between March 2012 and to February 2016. It might be pertinent to inform EPA that legal proceedings (with regard to wholesale breaches of Irish and European Environmental Law that have occurred surrounding the construction of the road in question, back in 2009) are set to issue as well as further legal proceedings in regard to land ownership and related issues around these lands.

EPA is probably aware of the Strategic Housing Development Application (No. 304066) that has been lodged with An Bord Pleanála for the construction of over 400 residential units and which proposes to use the illegally constructed road (the

subject of H0002-01) as access. It is difficult to see how SHD application can succeed in circumstances where the proposed access road is clearly in breach of EU Environmental Law.
