Dear Ruth,

As a person who is qualified, trained and experienced to the standard set out in section 2.3 of Code of Practice: Environmental Risk Assessment for Unregulated Waste Disposal Sites (EPA, 2007), it is my opinion that the Tier 2 and Tier 3 risk assessments carried out by Golder Associates Ireland Ltd on behalf of South Tipperary County Council in relation to Kilsheelan former landfill Site located at Kilsheelan, Co. Tipperary are adequate and complete. These assessments have been carried out under Golder's standard terms of appointment, limit of liability and standard of care (Golder proposals P0507190275/1/V.0 dated 31 August 2010 and P2507190001.P1.V0 dated 23 January 2012).

- Confirm that any future instances of environmental pollution will be detected in a timely manner, subject to all monitoring being undertaken as highlighted in the risk assessments, which includes validation monitoring to confirm the findings of the risk assessments.
