Thank you for your email yesterday and as per our phone call just now, please see below basis of calculation of the fee for each Waste Licence Application:

• 3.3 The disposal of waste (other than hazardous waste) at a facility (other than a landfill facility) where the annual intake is less than 25,000 tonnes. - €10,000

As per your below email, the Agency has determined that a €15,000 fee (allowing for 50%) waiver is payable given the proposed hazardous waste activity – my understanding as per Section 40 (2) of the Waste Management (Licensing) Regulations 2004 is that this €15,000 fee would replace the above €10,000 fee on the basis of it being the "highest of the fees specified". Therefore the fee payable for the 'disposal' activity would be €15,000.

As per the Licence Application form, two fees are payable where the proposed activities includes both recovery and disposal, as will be the case at this facility. Therefore, the following would apply:

4. The recovery of waste. - €10,000

My calculation, based on the above is that the correct fee would now be €25,000 for each application. Can you please confirm?

A fee of €30,000 is applicable to each site, given the proposed hazardous waste activity. However, the Agency is waiving 50% of the fees relating to the proposed hazardous waste activity (i.e. €15,000) in the case of the two waste licence applications and wish to advise that the total application fee for each application will be €35,000.
