TECHNICAL AMENDMENT D

Reasons for the Decision

The Environmental Protection Agency is satisfied, on the basis of the information available, that subject to compliance with the conditions of Licence Reg. No. W0165-02 granted on 23 March 2010, and amended on 2 August 2011, 15 January 2013, 15 November 2016 and 20 December 2013 as well as any amendments noted herein, any emissions from the activity will comply with and not contravene any of the requirements of Section 83(5) of the Environmental Protection Agency Act 1992 as amended.

A screening for Appropriate Assessment was undertaken to assess, in view of best scientific knowledge and the conservation objectives of the site, if the activity, individually or in combination with other plans or projects is likely to have a significant effect on any European Site. In this context, particular attention was paid to the European Site(s) at Deputy's Pass Nature Reserve SAC (000717), The Murrough SPA (004186), The Murrough Wetlands SAC (004186), Magherabeg Dunes SAC (001766), Wicklow Head SPA (004127), Vale of Clara (Rathdrum Wood) SAC (000733), Buckronev-Brittis Dunes and Fen SAC (000729), Wicklow Reef SAC (002274) and Wicklow Mountains SAC (002122).

The activity is not directly connected with or necessary to the management of any European Site and the Agency considered, for the reasons set out below, that it can be excluded, on the basis of objective information, that the activity, individually or in combination with other plans or projects, will have a significant effect on any European Site and accordingly determined that an Appropriate Assessment of the activity was not required.

The proposed amendment is solely to reduce the boundary to exclude a section of the site where no licensable activity has occurred. There is no waste buried in the area to be removed. There are no emissions, therefore there are no significant effects on the qualifying interests of the European sites.

Technical Amendment

In pursuance of the powers conferred on it by Section 96(1)(b) of the Environmental Protection Agency Act 1992 as amended, the Agency amends the licence, granted to Ballynagran Landfill Limited, Suite 3, One Earlsfort Centre, Lower Hatch Street, Dublin 2 for an installation located at Ballynagran, Coolbeg and Kilcandra, County Wicklow.

Henceforth, the licence shall be read in conjunction with a Section 82A(11) Amendment issued on 20 December 2013 and Amendment A issued on 2 August 2011, Amendment B issued on 15 January 2013, Amendment C issued on 15 November 2016, and the amendments set out below.



This Technical amendment is limited to the following Condition(s):

Amendments

Condition 1 Scope of the Licence

Amend Condition 1.2, of the licence to read as follows:

- 1.2 For the purposes of this licence, the facility is this area of land outlined in red on *Drawing No. 1006-IG 18-18* entitled “*Environmental Monitoring Locations*” of the technical amendment application received on 27th November 2018. Any reference in this licence to “facility” shall mean the area thus outlined in red.

This Technical amendment shall be cited as Amendment D, to the licence.
